Dear Honorable Representatives:

We, at PACTS, International, a non-profit 501 (c)(3) organization and members of our civilian Havana Syndrome community would like to thank you for your hearing held on May 8, 2024 entitled "Anomalous Health Incidents Targeting Americans in the Homeland" which was also re-broadcast on YouTube.

We are grateful that some of you specifically acknowledged that there were victims of AHIs that were non-governmental workers. Yes, there absolutely are! If this weaponry exists and is operating covertly, why would its use be limited to only US government personnel?

There are tens of thousands of us nationwide and perhaps hundreds of thousands of us worldwide in our Internet community. The world's most well-kept secret is that essentially all developed countries and even most developing countries have access to directed energy weapons (DEWs) and are using them domestically to control their populations. These devices have been marketed worldwide and are an easy sell to most governments that seek covert dominance of their citizenry.
